1. Welcome/Introduction

JH welcomed all attendees to the meeting, along with guests Alison Lewis and Bethan Hopkins from Audit Wales who were attending as observers. Apologies were noted.

JH explained the meeting would be in two parts. Part 1 will cover business from the meeting scheduled for 12th September which was postponed. Part 2 will be a future priority setting workshop

2. Minutes of meeting held 16.05.2022

The meeting notes from 16 May 2022 meeting were agreed for accuracy with no comments noted. KB confirmed status on action plan and provided updates on progress made with the current action plan table, which were noted.

JH formally thanked Sian Howys, Statutory Director of Social Services for Ceredigion County Council for her work with the WWRPB and wished her well for her retirement.

3. NEST Action Plan for Agreement

SB presented the NEST/NYTH action plan, providing a detailed overview. The NEST Framework is a planning tool for Regional Partnership Boards that aims to ensure a 'whole system' approach for developing mental health, well-being and support services for babies, children, young people, parents, carers and their wider families across Wales

SB confirmed Alder Advice, who have previous experience with the "No Wrong Door" approach in North Wales, had been successful in tendering for the contract to assist us in undertaking review against the NEST framework and developing an action plan.

A questionnaire, which will inform the action plan has been circulated to relevant stakeholders, the findings of which will be compiled and shared in the new year.

JH thanked SB for the progress that ahs been made on this agenda during the last year.

2. Carers Annual report for Agreement

PM provided a detailed overview of the 2021/2022 Carers Annual Report for endorsement by the RPB.

JH thanked PM for collating and presenting the report, which was commended by both her and HLL and endorsed by the board.

KB asked the board to note WG had confirmed an allocation of £9m for the All-Wales short break fund. PM added that the Carers Trust are lobbying for a change of terminology from respite to "Carers Break".

HLL expressed concern over the impact of the current cost of living crisis on unpaid carers. PM gave an example of the Pembrokeshire "Keep warm, Keep well" initiative that was being developed locally.

4. Social Value Forum

EB provided an overview of the report, highlighting progress made in setting up the West Wales Social Value Forum. RPB is required to submit a triennial report to WG.

The forum aims to support innovation and promote the social value sector. A face-to-face meeting of the forum was held in Narberth earlier in the year and a further virtual meeting will be held in November. Practice Solutions are supporting this work and an update will be provided within the new year.

JH thanked EB for the report and update on progress.

Part 2 Future Priorities Workshop

A workshop approach was taken to discuss future priorities. KB outlined the purpose of the workshop was to:

- Reflect on the Achievements of last 12 months
- Consider Findings of Population Assessment & Market Stability Report
 Discuss priorities together

A summary of the findings will be compiled and presented to members at next RPB meeting.
